

**19 CRIMES FIND THE 19<sup>TH</sup> CORK PROMOTION**  
**OFFICIAL RULES**

The 19 Crimes Find the 19<sup>th</sup> Cork Promotion (“Promotion”) is sponsored by Treasury Wine Estates Americas Company (“Sponsor”), 555 Gateway Drive, Napa, CA 94558 and is administered by Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **PROMOTION TIMING:** The Promotion begins on January 4, 2022 at 12:00 PM (noon) Eastern Time (“ET”) and ends on February 28, 2022 at 11:59:59 PM ET (“Promotion Period”). The Promotion includes a grand prize drawing (“Grand Prize Drawing”) and the following eight (8) entry periods (each, an “Entry Period”):

Non-winning entries will carry forward into subsequent Entry Period drawings. The Administrator’s computer is the Promotions’ official clock.

2. **ELIGIBILITY:** The Promotion is offered only to legal residents of the fifty (50) United States (excluding Utah), the District of Columbia, and Canada (excluding Quebec) who are at least twenty-one (21) years of age or of legal drinking age in his/her province or territory of residence. Employees,

officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All applicable federal, state, provincial, territorial, and local laws and regulations apply. Void in Utah, Puerto Rico, all other United States territories, Quebec and where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

HOW TO ENTER THE PROMOTION:** During the Promotion Period, an eligible entrant may visit 19thcork.com ("Website") and enter his/her date of birth and e-mail address, and complete and submit the online registration form in full and as instructed, which may include, but is not limited to, complete first and last name (no initials), street address (no P.O. box), city, state, ZIP code, date of birth, phone number, where Entrant heard about 19 Crimes, and confirmation Entrant has read and agrees to be bound by these Official Rules. All fields on the entry form must be completed unless they are indicated as optional. Upon subsequent visits, entrant will only need to enter his/her email address. After submitting the required information, entrant will automatically receive ten (10) entries into the prize drawing.

**Limit:** An entrant may receive ten (10) entries for registering for the Promotion during the Promotion Period. An entrant will receive no more than the stated number of entries during the Promotion Period. If more than the stated number of entries is received from the same person, telephone number and/or e-mail address on any given day during the Promotion Period, the entries may, at the Sponsor's sole discretion, be disqualified.

**Mail-In Without Uploading a Photo:** To earn a Sweepstakes entry without uploading a photo, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY), on a 3½"x5" card ("Mail-In Entry") and mail it (in an outer mailing envelope) with

Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

- C. Follow Sponsor on Instagram:** During the Promotion Period, an entrant may follow the links and instructions to follow Sponsor on Instagram @19crimes. Upon following Sponsor on Instagram, entrant will receive ten (10) entries into the Grand Prize Drawing. Limit: Entrant may follow Sponsor on Instagram one (1) time during the Promotion Period.
- D. Share on Facebook and Twitter:** During the Promotion Period, an entrant may obtain up to twenty (20) additional entries by following the instructions on the Website and set forth below to share the Promotion on Facebook and Twitter. Upon clicking the buttons to share the Promotion, a message with a unique link will be posted to the entrant's choice of his/her Facebook Wall or Twitter Feed ("Invitation Post"). To obtain additional entries, an entrant's Facebook "Friend" or Twitter "Follower" must click on the unique link in the Invitation Post and complete and submit the registration information requested, and enter the Promotion. Upon the Friend's/Follower's successful entry into the Promotion, the original entrant will receive one (1) entry into the Grand Prize Drawing. Upon creating an Insiders Loyalty Program account, entrant will receive nineteen (19) entries into the Grand Prize Drawing for signing into or creating a 19 Crimes Infamous Insiders Loyalty Program account. Entrant may sign in or create an account one (1) time during the Promotion Period.
- F. Enter Free Codes:** During the Promotion Period, Sponsor will post photos and videos on Sponsor's Instagram page @19crimes. Each photo/video will include one (1) hidden code ("Code"). There will be eight (8) total Codes available during the Promotion Period. One (1) Code will be posted per Entry Period and each Code must be entered during the respective Entry Period to receive an Entry Period entry. Upon finding a Code, entrant may visit the Website and follow the links and instructions to enter the Code. Upon entering a Code, entrant will receive one (1) entry into the respective Entry Period and one (1) entry into the Grand Prize Drawing. Limit: Entrant may enter one (1) of each Code during the Promotion Period. Each Code may only be entered one (1) time. If an entrant enters a Code from an earlier Entry Period Code he/she will only receive an entry into the Grand Prize Drawing and not the respective Entry Period.

**Bonus Code Entry:** If entrant enters all eight (8) Codes, he/she will receive sixteen (16) bonus entries into the Grand Prize Drawing only.

**4. RANDOM DRAWING:** On or about March 11, 2022, Administrator will select one (1) potential grand prize winner from among all eligible entries received from all Canadian entrants and one (1) potential grand prize winner from among all eligible entries received from all United States entrants. On or about each Drawing Date listed in Section 1, Administrator will select potential secondary prize winners, in the quantities listed in the Section 5B table below, in a random drawing from among all eligible entries received during the applicable Entry Period. Each winner is deemed to be a potential winner, pending verification of the entrant’s eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion. Canadian residents will be required to correctly answer a timed mathematical skill-testing question as further described in Section 6 before being declared a potential winner.

**5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

**A. Grand Prizes (2 total 1 for a US winner and 1 for a Canadian winner):** Each grand prize is \$19,000 USD (each a “Grand Prize”). The ARV of each Grand Prize is \$19,000 USD / \$19,000 CAD. No more than two (2) Grand Prizes will be awarded in the Promotion, one (1) for a US winner and one (1) for a Canadian winner.

No more than the above listed quantities of Secondary Prizes will be awarded. The ARV of all available Secondary Prizes is \$2,975 USD/ \$3,763.52 CAD.

**C. Total ARV:** The total ARV of the prize available in this Promotion is \$19,830 USD / \$25,085.94 CAD\*

\* All currency conversions based on listed exchange rate as of November 19, 2021.

**D. Odds of Winning:** The odds of winning a Secondary Prize depend upon the number of eligible entries received during each Entry Period. The odds of winning a Grand Prize depend upon the number of eligible entries received during the Sweepstakes Period.

**E. General:** There is a limit of one (1) Grand Prize and one (1) Secondary Prize per person. In no event will more than two (2) Grand Prizes (one [1] for a US winner and one [1] for a Canadian winner) and seventy-six (76) total Secondary Prizes, be awarded. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
